### Summary of reasons for decision:

The availability of the computer moving image file is restricted to persons who have attained the age of 18 years because it contains a video clip showing a naked young man and woman engaging in sexual conduct. Society in general perceives an injury in children and younger teenagers being exposed to explicit sexual material before they are ready. Young people do not have the maturity and experience to deal with sexual scenes intended for adult viewers.

The Classification Office has considered the effects of the New Zealand Bill of Rights Act 1990 on the application of all the classification criteria. The classification given to this publication places a limit on the freedom of expression, but the availability of the file to children and young people is likely to be injurious to the public good. The classification is reasonable, demonstrably justifiable and the minimum required to avoid injury.

## Summary of reasons for decision:

The availability of the computer moving image file is restricted to persons who have attained the age of 18 years because it contains a brief video clip whose introductory set-up attempts to titillate viewers with suggestions of coercion and underage sex. However, this initial scenario is unconvincing and explicit images of adult sexual activity follow. Given the brevity and lack of context for the clip, a restriction to adults is sufficient to limit any likely injury to the public good from the file being available. Young people do not have the maturity and experience to deal with sexual scenes intended for adult viewers.

The Classification Office has considered the effects of the New Zealand Bill of Rights Act 1990 on the application of all the classification criteria. The classification given to this publication places a limit on the freedom of expression, but the availability of the file to children and young people is likely to be injurious to the public good. The classification is reasonable, demonstrably justifiable and the minimum required to avoid injury.

## Summary of reasons for decision:

The magazine is classified as objectionable because it tends to promote and support the exploitation of young persons for sexual purposes.

The magazine is a glossy, sexually orientated British periodical targeted at young adult men. It features photo-spreads of young, scantily clad women with their buttocks and breasts visible, interspersed with interviews and satire, and sections on drinking, fashion, consumer electronics and music. There are two pages of explicit phone sex advertisements, most of which depict young female models in sexualized poses. Many of these models present as younger teenagers or are accessorised to look like adolescents, and the accompanying text reinforces their youthfulness with multiple references to virginity, innocence, naïveté, and being under home supervision. Statements that the girls are "18+" do little to counter the effect. The advertisements encourage sexual interest in young persons and promote them as sexually available and appropriate objects of adult sexual fantasy.

The classification of this publication interferes with the freedom of expression as set out in the New Zealand Bill of Rights Act 1990. However, this is an outcome that is consistent with Parliament's intention that publications which fall under the criteria of s3(2) of the Films, Videos, and Publications Classification Act 1993 will be deemed objectionable. The classification is a reasonable and demonstrably justified limitation on the freedom of expression that reflects the concern of a free and democratic society to protect young people from exploitation.

This DVD contains extra material relating to a feature that has been previously classified. The feature was originally examined as a 35mm film by the Office of Film and Literature Classification (OFLC No. 1000675, registered on 11 May 2010). The DVD contains a feature that has previously been classified in Australia and cross-rated by the Film and Video Labelling Body as M, with the descriptive note 'Contains violence and offensive language'.

The extra material includes a number of gag reels and bloopers, three trailers, and a number of deleted scenes. The deleted scenes have stronger content and altogether have a harsher tone than the feature. In particular, the increased extent and degree of the sexual content and highly offensive language require the DVD to be given a higher classification than the original feature. A restriction on the availability of the DVD to teenagers and adults will be sufficient to minimise the risk of injury to the public good while keeping it available to its intended audience.

This restriction is a reasonable limitation on the freedom of expression contained in the Bill of Rights, and is demonstrably justified in a free and democratic society. It is the minimum restriction that can be applied in order to prevent injury to the public good.

#### Summary of reasons for decision:

The publication is a DVD containing a sequel to a well-known horror film and a number of extra components relating to its development and marketing.

The availability of the publication is likely to be injurious to the public good. The feature is an unsubtle portrait of a sexually deranged man who tortures a group of largely anonymous victims in extreme, unflinching detail. Despite the occasional flashes of humour and a degree of sub-textual irony, these elements are overwhelmed by the feature's sustained, gratuitous focus on victims' torture, mutilation, forced defecation, rape and murder. These images are linked by a threadbare plot that provides limited narrative justification. While the feature does not promote or support this material, the likely injury to the public good is one of inuring people more generally to cruel, violent and degrading material through its presentation as entertaining, and of eroding the viewer's ability to empathise with others. This material would disturb and shock most people.

Consideration was given to offering excisions in order to remove the strongest images, however due to the pervasiveness of this material excisions were not deemed practical. While the classification is an absolute restriction on the freedom of expression as contained in the New Zealand Bill of Rights Act 1990, it is a restriction consistent with Parliament's intention that publications containing such a high extent and degree of torture, violence, cruelty, sexual violence and strongly degrading, dehumanising and demeaning material can be classified as "objectionable" to prevent the likelihood of injury to the public good.
