The publication contains additional content derived from, and designed to be played in conjunction with, a console game originally examined and classified by the Office of Film and Literature Classification ("Fallout: New Vegas", OFLC No. 1001333.000, registered 20th August 2010). It was classified "Objectionable except if the availability of the publication is restricted to persons who have attained the age of 18 years" and given the descriptive note "Graphic violence and content that may offend".

This computer game expansion pack comprises four new components (Dead Money, Honest Hearts, Old World Blues, and Lonesome Road) that continue the post-apocalyptic theme of "Fallout: New Vegas". These extra components deal with matters of horror, cruelty and violence in a similar manner to the original game, and do not require this expansion pack to be given a different classification.

The publication's sexual violence and violence in association with sexual conduct is concerning in a different way. Research has repeatedly shown that such depictions are likely to reinforce negative attitudes towards women in a number of ways. They have been shown to desensitise viewers to real-life violence, to reduce empathy with victims of sexual violence amongst both men and women, to increase rape myth acceptance, and to increase women's fear of sexual assault. In the current publication this material is so extensive and extreme that these injuries to the public good are likely to occur regardless of the age of the viewer. The publication is characterised by a significant level of dispute over its claims to merit, value and importance.

While the classification places a restriction on the freedom of expression as contained in the New Zealand Bill of Rights Act 1990, it is a restriction consistent with Parliament's intention that publications containing such a high extent and degree of sexual violence and violence in association with sexual conduct, along with sexual conduct with children and young persons, be classified as "objectionable" to prevent the likelihood of injury to the public good.
